### **Amended decision regarding proposed dividend**

Absolent Group AB's Board of Directors has decided to withdraw the previously indicated dividend proposal to the Annual General Meeting for 2020 of SEK 1.8 per share. The decision was made despite Absolent Group's healthy financial position and does not signal a change in the Group's dividend policy or future ambitions for dividend.

The decision comes from the current uncertainty resulting from the impact of the Covid-19 pandemic. The Board of directors has chosen to withdraw the dividend proposal indicated to the Annual General Meeting as a precautionary measure and in order to gain a better overview of the consequences of Covid-19, as well as to ensure financial flexibility.

The board of directors have decided to propose, to the Annual General Meeting on May 5, 2020, that no dividend is paid.
